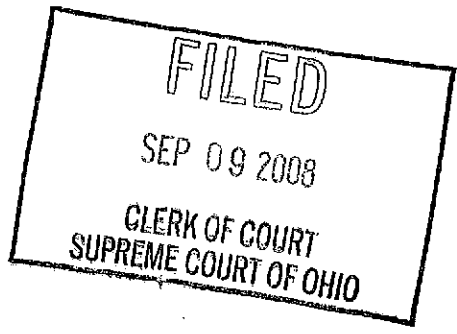

**APPELLEE'S MERIT BRIEF**


